## THE ORGANISATION

### Forty years of community impact and a merger that raised the stakes

gforce Employment + Recruitment has spent more than 40 years making a meaningful difference in the lives of people across regional and suburban Victoria. As a for-purpose community organisation, gforce's work sits at the intersection of employment services, community support, and long-term social impact.

In 2025, gforce and MEGT, two organisations with remarkably aligned values and histories, completed their merger, effective 1 July 2025. The combined entity is better positioned to serve employers, job seekers, and communities across Australia. But to do that well, they needed their financial operations to reflect the strength of that union, not the complexity of two separate systems running in parallel.

## THE CHALLENGE

### Two systems, one deadline, and no margin for disruption

gforce was operating on Tencia while MEGT was already on NetSuite. With the merger in effect and a financial year-end approaching, the priority was clear: migrate gforce onto MEGT's NetSuite environment and give the combined organisation a single, unified view of its finances.

For any finance leader who has been through a merger, the challenge is familiar. Two charts of accounts. Two sets of processes. Two teams who each have their own way of doing things and a business that cannot afford to stand still while the transition happens.



#### For gforce and MEGT, the specific pressures included:

- ✘ No consolidated financial view across the combined organisation while operating on separate systems
- ✘ A compressed timeline go-live was needed well ahead of financial year-end
- ✘ Migrating gforce's processes into MEGT's existing NetSuite environment without disrupting what was already working
- ✘ Building a multi-entity structure that met gforce's subsidiary requirements and was designed to accommodate future acquisitions
- ✘ Establishing AP controls, approval workflows, and compliance reporting fit for a combined organisation of this scale

## THE SOLUTION

### A platform built for today and designed for what comes next

The decision to work with OneKloudX was straightforward. MEGT had a strong prior relationship with the team, and that existing trust meant the project could move quickly without the usual early friction of a new partnership. From kick-off, the engagement was collaborative, structured, and focused on outcomes, not just deliverables.



#### A Unified Multi-Entity Architecture

OneKloudX built a subsidiary structure within NetSuite that accurately reflected gforce's reporting entities with segment restrictions enforced per subsidiary and non-reporting entities locked down to prevent mis-posting. The architecture was designed to match MEGT's existing processes with future acquisitions in mind, giving the combined organisation a platform that can absorb growth without requiring a rebuild.



#### Automated Accounts Payable

The AP function was transformed. Invoices now flow directly into the system via email or supplier portal; nothing gets lost in an inbox. OCR technology captures invoice data across all subsidiaries automatically. Duplicate invoice detection prevents double payments. The result is an AP team that spends its time on oversight and exceptions, not manual processing.



### Policy-Driven Approval Workflows

Vendor bills are routed automatically in line with the organisation's Delegation of Financial Authority policy. Approvers can reject bills, document reasons, and return them for correction. Approval delegation handles periods of leave without breaking the chain. The entire process is auditable, traceable, and no longer dependent on individual follow-up.



### Supplier Controls and Payment Integrity

Changes to supplier bank details require approval before taking effect, a simple but critical control that protects against payment fraud. Automated remittance advice is sent to suppliers at the point of payment, reducing inbound queries and managing expectations proactively.



### Real-Time Reporting and Financial Visibility

For the first time, leadership has a consolidated, real-time view of the entire organisation's finances in one place. AP aging, fixed asset reports, customer aging by payment terms, and BAS and PAYG compliance reporting are all available on demand. Financial data flows directly into Cognos for CFO-level planning and forecasting, no manual extracts, no waiting.

## THE RESULTS

### Full visibility, real control, and a finance function built to scale

From kick-off to go-live in under four months, gforce and MEGT now operate as one, on one platform, with one version of the truth. But the real measure of success isn't the timeline. It's what the finance team can do now that they couldn't before.



#### One source of truth

Leadership across both organisations has a single, real-time view of consolidated finances, replacing disconnected systems with the clarity needed to make faster, more confident decisions.



#### Finance teams that run leaner

Automated invoice capture, approval routing, and remittance advice have freed the AP team from manual processing, shifting their focus to financial oversight and strategic support.

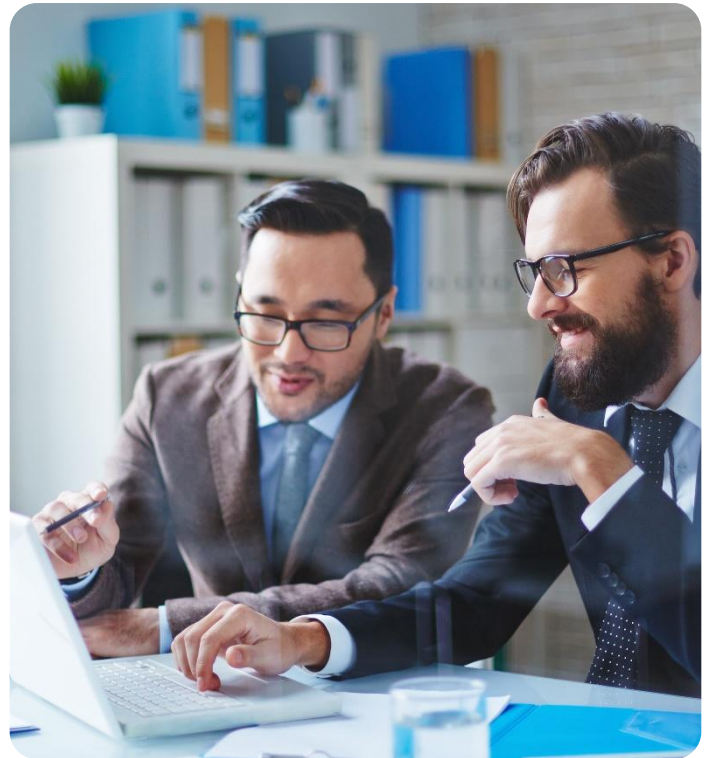
### Compliance built in, not bolted on

DFA-based approvals, supplier payment controls, and subsidiary restrictions are embedded directly into the system. Compliance is enforced by design, not by individual vigilance..



### Reports when you need them

AP aging, fixed assets, consolidated financials, and BAS reporting are available on demand, without manual aggregation, month-end waits, or chasing the finance team.



The difference in our day-to-day is significant. Approvals that used to require chasing are now automatic. Reports that took days to pull together are available instantly. The team is spending its time on work that actually matters."
